RECEIPT OF MEMBERSHIP PLAN

If approved for membership, the undersigned agrees to release and discharge Grand Club Partners, doing business as Grand Bay Club (the "Club"), its partners, affiliates, employees and agents from any and all claims and causes of action the undersigned may have against the Club regarding the Grand Bay Club Facilities.

PAYMENT OF INITIATION FEE

The undersigned hereby applies for membership in the Club. The undersigned agrees to submit payment of the Initiation Fee of \$16,500.00 with this application.

NON-REFUNDABLE NATURE OF INITIATION FEE AND CONDITIONAL ASSIGNABILITY OF SUCH FEE

I understand that in the event that this Application for Membership Privileges is not approved by the Club, the Initiation Fee which I have paid to the Club shall be refunded to me within thirty (30) days of my having received notice of non-approval. I hereby acknowledge that during the pendency of the application process, my Initiation Fee will not bear any interest.

I understand that if this application for membership privileges is approved, the initiation fee which I have paid to the club shall immediately become non-refundable and be deemed earned by the club; provided, such initiation fee may be transferable to any new applicant referred by member requesting the transfer and which is approved by the club, all in accordance with the then existing membership fee(s) assignability program, which program may be amended from time to time at the club's sole discretion and without notice.

PAYMENT OF DUES, FEES, AND CHARGES

The Club may require, in its discretion that all dues, fees and charges be charged to: (i) my club account, (ii) a credit card account through a company selected by the Club, or (iii) any other of my credit cards. I hereby acknowledge that all food, beverage, merchandise and services of the Club charged to my club account shall be billed monthly and shall be due and payable upon receipt of the monthly statement. I hereby further acknowledge that yearly dues of \$4,380.00 can be billed and payable on a monthly basis, on or before the first day of each month, unless otherwise determined by the Club from time to time.

DELINQUENT ACCOUNTS

I understand that my club account shall be considered delinquent if not paid within thirty (30) days after the date of the monthly statement and will be subject to a one and one-half percent (1½ %) late charge per month from the date of the monthly statement until paid in full. Delinquent accounts for a period of thirty (30) days after written notice shall be a cause for (i) suspension of membership privileges, and/or (ii) expulsion from membership in the Club. I acknowledge that the Club may take whatever action it deems necessary to effect collection, including without limitation, suspension or termination of my membership or legal action, and I shall be liable for all costs and for any expenses of such legal action and reasonable attorneys' fees, including any fees required in connection with any and all appellate proceedings.

I authorize the Club to charge my credit card(s) for all charges in the event my account becomes thirty (30) days past due. A current credit card must be on file with the Club at all times.

APPROVAL FOR MEMBERSHIP IN THE CLUB

I understand that this Application for Membership Privileges will be subject to approval by the Club, in its sole and absolute discretion, and my payment of the required Initiation Fee, dues, other fees and charges established by the Club from time to time. I hereby acknowledge that this Application for Membership Privileges will not be acted upon unless fully completed, signed, and the Initiation Fee having been received by the Club. I hereby acknowledge that my membership constitutes a revocable license to use the Club Facilities and does not confer upon me any ownership interest in the Club or the Club Facilities and does not confer upon me any vested or prescriptive right or easement in or to use the Club Facilities.

VERIFICATION OF APPLICATION

Upon signing this Application for Membership Privileges, I hereby authorize the disclosure and release of information to the Club for investigating my qualifications for membership and authorize those persons or entities herein to furnish information to the Club, including providing a credit report to the Club.

HOLD HARMLESS

I hereby acknowledge that the use of the Club Facilities and any privilege or service incident to membership is undertaken with knowledge of the risk of possible injury. I hereby accept any and all risk of injury to myself, my guests and my family sustained while using the Club Facilities or involved in any event or activity incident to membership in the Club. In accepting the risk of injury, I understand that I am relieving the Club and any and all of its shareholders, directors, officers, employees and affiliates from any and all loss, cost, claims, injury, damage or liability sustained or incurred by me, my guests and my family resulting from or arising out of any conduct or event connected with membership in the Club and use of any of the Club Facilities.
